## Valued Industry Partner Award




The AGM ended with a simple buffet dinner for all present.

The National Trade Union Congress (NTUC) presented CILTS with an award on its collaboration on digital training at the NTUC May Day Award Ceremony.



## Hong Kong Education Bureau Site Visit



CILTS arranged for them to visit the URA City Gallery, 3M Innovation Centre, Yishun Regional library, Republic Polytechnic and NUS Advanced Robotics Centre and autonomous vehicles facilities.



## CILTS/PSB Academy Evening Lecture

An evening lecture, jointly organised by CILTS and PSB Academy, was presented by Dr Tomoo Kikuchi, Visiting Senior Fellow, S Rajaratnam School of International Studies, Nanyang Technological University on 26 September 2018. The topic of the lecture was “Can the Kuala Lumpur - Singapore High Speed Rail (HSR) project make operational profit?”

Addressing the question, Dr Kikuchi pointed out that the population density in the Kuala Lumpur - Singapore HSR may not be high enough to make the HSR profitable. To improve the profit margin, the HSR has to help strengthen Kuala Lumpur and Singapore's status as regional economic hubs. Dr Kikuchi pointed out that the profitability of HSR will depend on the extent of regional economic integration and how urban clusters unfold within ASEAN member states.

## Urban Traffic Management Training
