MINUTES OF THE 40TH ANNUAL GENERAL MEETING Held on Friday, 12 April 2013 At The Chartered Institute of Logistics and Transport Singapore 5 Jalan Kilang Barat, #06-03 Petro Centre, Singapore 159349

Present: 29 members

1. Agenda Item 1 Welcome Address by Chairman

- 1.1 At 6.30 pm, the meeting was adjourned for half an hour due to the lack of quorum. At 7.10 pm, Chairman Karmjit Singh called the meeting to order and extended a warm welcome to members and guests.
- 1.2 Chairman highlighted the major events and initiatives for 2012, which included the following:-
 - Visit by CILT International President, Dr. Dorothy Chan to CILTS. Dr Chan expressed her support in promoting CILTS e-learning Supply Chain Professional Development (SCPD) Programme to other CILTs.
 - Transportation and Logistics Study Visit to China, jointly organised by LTA Academy and CILTS. Led by Chairman and Director Loh Chow Kuang, the delegates visited the Guangzhou Knowledge City, Guangzhou-Shenzhen high speed train network and Nan Sha Development District.
 - Launch of Cold Chain courses "Cold Chain Solution Planning & Implementation" and "Clinical Trial Requirements for Cold Chain Logistics Suppliers". Three rounds of the courses were conducted and these were well received by participants.
 - Launch of the Professional Development Course in Maritime Logistics. Eligible course participants received a 50% subsidy from the Maritime and Port Authority of Singapore (MPA) Maritime Cluster Fund, which was subsequently increased to 70%.
 - Workshop on "Smarter Supply Chain Executive in Fulfilling Global Ecommerce", jointly organised by CILTS and the Singapore Management University.

2. Agenda Item 2 To receive and adopt the minutes of the 39th AGM held on 20 April 2012

2.1 The minutes of the 39th AGM were adopted at the meeting, as proposed by Dr Tan Poi Sik and seconded by Mr Sam Man Keong.

- 3.1 Honorary Secretary Ivan Neo expressed the Board's appreciation to the following outgoing members of the CILTS Advisory Panel:
 - CILTS Principal Advisor Mr Chandra Das, Managing Director of NUR Investment and Trading
 - Mr Didier Chenneveau, President of CEVA Asia Pacific
 - Mr Barry Desker, Dean of the S Rajaratnam School of International Studies, Nanyang Technological University

Honorary Secretary welcomed Mr Thomas Riber Knudsen, the CEO of Maersk Line (Asia Pacific) to the Advisory Panel

With these changes, there are currently 19 members on the Advisory Panel, covering wide spectrum of the logistics and transportation industry

- 3.2 Chairman informed members that the Board is strongly focused on infusing new blood into the Advisory Panel as well as the Board. Over the years, Chairman has been urging members at AGMs to volunteer their services on the Board. Unfortunately, this has not yielded success and all the fresh faces on the Board were the result of concerted persuasive efforts by Chairman and Directors in approaching individual members. Chairman had also highlighted this to visiting senior CILT Internaltional officials, including the then CILT International President Alan Waller when he visited CILTS in 2012.
- 3.3 Chairman shared that a member had brought up the subject of succession planning in a recent email to CILTS. Chairman added that this matter has been a pressing priority for the Board, which even looked at other ways of easing members into leadership roles, including setting up a youth wing several years ago.
- 3.4 Honorary Secretary reviewed the developments in membership and key activities undertaken by the Institute during the year of review.
- 3.5 Compared to the previous year, there was an increase in paid individual membership from 180 to 246 in 2012. The corporate membership also increased from 6 to 13. The Institute will step up efforts to draw more new members and to retain existing members with greater value propositions and engagement.
- 3.6 The 2012 run of the CILTS-Republic Polytechnic Exclusive Programme on Supply Chain Management was conducted on 7-29 March. The 20 students who passed the examination were presented their certificates at the 2012 AGM.

- 3.7 CILTS and the LTA Academy jointly organised the Transport and Logistics Study Visit to China from 4 to 9 April 2012. Chairman and Director Loh Chow Kuang led the team.
- 3.8 The CILTS 39th Annual General Meeting cum Certificate Presentation Ceremony was held on 20 April 2012. 30 members and 16 observers/certificate recipients attended the meeting.
- 3.9 The annual briefing on the Certified Professional Logistician Programme (CPL) was held on 15 May 2012 at IE Singapore. The 2012 batch of CPL opted for the e-learning SCPD to prepare for their certification examination. All passed the examinations and received their certificates at the 2013 AGM.
- 3.10 The inaugural Professional Development Course in Maritime Logistics was held on 23-25 May 2012. A 50% course fee subsidy from MPA's Maritime Cluster Fund was awarded to eligible participants for the first programme. For the second course, which was held on 3-5 October 2012, the subsidy was raised to 70%.
- 3.11 Honorary Secretary reported that during the year, CILTS launched two cold chain programmes, namely "Cold Chain Solution Planning & Implementation" and "Clinical Trial Requirements" for cold chain logistics suppliers. Three rounds of the courses were conducted during the year.
- 3.12 A Workshop "Smarter Supply Chain Executive in Fulfilling Global E- commerce", jointly organised by CILTS and the Singapore Management University (SMU) was conducted on 6 August 2012. The workshop was held at SMU and Chairman Karmjit Singh was a member of the discussion panel.
- 3.13 Two courses on Logistics for Dangerous Goods & Hazardous Materials Handling were conducted during the year due to strong demand from the logistics sector.
- 3.14 During the year, CILTS participated in a few conference exhibitions, including at the 2nd Hi-Tech & Electronics Supply Chain Summit Asia Pacific and the Life Science Supply Chain Summit. At these conferences, CILT took the opportunity to promote CILTS membership to conference delegates and to market its training programmes.
- 3.15 A key highlight of the year was the visit of Dr Dorothy Chan, then President Elect of CILT International. Dr Dorothy Chan, of CILT Hong Kong, commented on the high standards of our e-learning SCPD programmes and expressed interest in promoting them to CILTs around the world.

3.16 A/Prof Rajesh Piplani proposed that the Annual Report be accepted. This was seconded by Ms Emily Tan.

4. Agenda Item 4

To receive and adopt the Financial Report for the year ending 31 December

- 4.1 Director Special Projects Chia Peck Yong, on behalf of Honorary Treasurer Loh Chow Kuang, who was away on business travel overseas, reviewed the financial accounts. He reported that the Institute made a surplus of \$28,730 for the year, reversing the deficit of \$26,636 for 2011. This was mainly due to the many short courses conducted during the year, which offset the absence of revenue contributions from a major conference. Additionally, stringent control on expenses kept the costs down.
- 4.2 Dr Tan Poi Sik Proposed that the Financial Accounts be accepted. This was seconded by Mr Kenneth Tan.

5. Agenda Item 5

To elect Members to the Board of CILTS for 2013 and 2014

- 5.3 Chairman thanked all outgoing members for their past contributions and current and new members for volunteering their services and time to serve on the Board.
- Chairman reiterated his repeated calls over the years for able and committed members to step forward to lead the institution, and bring it to the next level. This has become an urgent task as only a handful of new members have joined the Board. He added that the introduction of Executive Committee of the Board and Board of Trustees last year was part of the succession plan to attract more new

6. Agenda Item 6

To appoint Mr PE Ashokan of Messrs Khattar Wong as the Honorary Legal Advisor for the ensuing year

6.1 Honorary Secretary Ivan Neo proposed the appointment of Mr PE Ashokan of Messrs Khattar Wong as the Honorary Legal Advisor. This was seconded by Mr Seow Aik Hoe.

7. Agenda Item 7

To appoint Messrs Wu Wai Hong & Co as the External Auditor for the ensuing year

- Dr Tan Poi Sik asked whether there was a limit to the years for the same external auditor to be appointed. Honorary Secretary, on behalf of Honorary Treasurer, replied that there is no limit as the Constitution has not specified this. Nevertheless, the Board would look into the matter.
- 7.2 Mr Chia Peck Yong proposed the re-appointment of Messrs Wu Wai Hong & Co as the External Auditor. This was seconded by Mr Thomas Ng.

8. Agenda Item 8

To consider any other business of which at least seven (7) clear days' notice has been given to the Honorary Secretary

- 8.1 Honorary Secretary informed the meeting that the Secretariat had not received any notification from members to consider any other business during the AGM. The Board has submitted the proposal "Investment of Surplus Funds" to seek members' views and endorsement.
- 8.2 At the end of financial year 2012, CILTS has accumulated a surplus fund of about \$800,000 in cash and fixed deposits in banks, earning a marginal 0.35% interest per annual. The Board proposed to invest about \$700,000 of the surplus funds in investment grade bonds, blue chip stocks and real estate investment trusts to

- 8.3 Dr Tan Poi Sik advised that bank charges, management fees and related charges be taken into account to determine the quantum of returns. He also suggested breaking the proposed investment amount into smaller portions to facilitate subsequent cash
- 8.4 Thanking Dr Tan Poi Sik for his inputs, Chairman pointed out that certain bonds, such as Fullerton Fund from DBS Bank, are yielding 3 to 5% net interest returns. More enquiries with financial institutions are being made for the purpose of comparison, including consulting other establishments, such as the SIA Group Sports Club. Chairman emphasised that the Board would exercise prudence and be conservative, taking risk factors into consideration before investment decisions are made. This was one of the reasons why surplus funds have not been invested earlier.
- 8.5 Honorary Secretary, Ivan Neo, who is on the Management Committee of SIA Group Sports Club and knows the investment policy of the club, will help set up the guidelines for investment of funds for CILTS and table this for CILTS Board for approval.
- 8.6 There being no further inputs and queries, members agreed that the Board will proceed with the investment of surplus funds of up to \$700,000 in investment grade bonds, blue chip stocks and real estate investment trusts.
- 8.7 With no matters arising, the meeting ended at 8.00 pm with a vote of thanks to the Chair.

Objectives and Aims of CILT Singapore

The Chartered Institute of Logistics and Transport (CILT) is the professional body for those engaged in logistics, transport and physical distribution covering all sectors of the industry, namely, land, sea, air and logistics, for both passenger and freight transportation. It was formed in United Kingdom in 1919 as the Institute of Transport and granted a Royal Charter in 1926. It was renamed as the Chartered Institute of Logistics and Transport (CILT) in 2000. The Singapore Group was formed in 1971. It was converted to a Section in 1986 and to a National Council in 1991.

Objectives

To promote, encourage and co-ordinate the study and advancement of the science and art of logistics and transport through the organisation and conduct of appropriate activities and services.

To do research into the best means of developing and improving logistics, transport and physical distribution by every practical means and in the best interest of the community.

To educate men and women engaged in logistics, transport or physical distribution, or in any of the many activities connected with the movement of people or goods, so that they may acquire the knowledge they need to obtain the Institute's qualifications.

Recognition, Role & Membership of CILT Singapore

Fellowship (FCILT), Chartered Membership (CMILT) and Membership (MILT) of CILT are widely recognised as the qualifications required for those involved in logistics and transport. Members of CILT are on the Boards of or hold management posts in most major logistics and transport undertakings. Membership of CILT is encouraged by logistics and transport employers both in the public and private sectors, who regard acceptance into the CILT as an important step in advancing the professional careers of individuals in the industry.

Those who are Member grade and above are eligible to use the designatory letters, FCILT for Chartered Fellow, CMILT for Chartered Member and MILT for Member. This not only signifies membership of a professional body, which has worldwide representation, but is also the mark of a very high standard of educational/professional achievement and practical experience in the logistics/transport industry.






